4. FIRST AID MEASURES

INHALATION: If adverse effects occur, remove to uncontaminated area. Give artificial respiration if not breathing. Get immediate medical attention.

SKIN CONTACT: Wash with soap or mild detergent and large amounts of water until no evidence of chemical remains (at least 15-20 minutes). Get medical attention if irritation develops or persists. Place contaminated clothing in a closed container until laundered or discarded. Contaminated clothing should be removed and laundered before reuse. Notify person laundering clothing of contaminant's hazardous properties. Discard contaminated leather goods.

EYE CONTACT: Flush eyes with plenty of water for at least 15 minutes. Hold eyelids away from the eyeball to ensure thorough rinsing. Get immediate medical attention.

5. FIRE FIGHTING MEASURES

FIRE AND EXPLOSION HAZARDS: Slight fire hazard. When water evaporates from this product, residues may contain ammonium nitrate and urea. Solid ammonium nitrate when sensitized during decomposition, may become unstable and explosive.

EXTINGUISHING MEDIA: carbon dioxide, regular dry chemical, regular foam, water

FIRE FIGHTING: Move container from fire area if it can be done without risk. Avoid inhalation of material or combustion by-products. Stay upwind and keep out of low areas. Cool containers with water spray until well after the fire is out. Apply water from a protected location or from a safe distance.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

STORAGE: Store and handle in accordance with all current regulations and standards. Store in a tightly closed container. Store in a cool, dry place. Store above 32 F. Protect from freezing. Store in a well-ventilated area. Avoid heat, flames, sparks and other sources of ignition. Keep separated from incompatible substances. Do not allow material to become dry.

HANDLING: Do not cut, puncture, or weld on or near this container. Do not breathe gas, fumes, vapor, or spray. When using, do not eat, drink or smoke.
